BUILDING INSPECTOR

<u>DISTINGUISHING FEATURES OF THE CLASS</u>: An employee in this class is responsible for administering and enforcing the New York State Uniform Fire Prevention and Building Code. The position entails a high degree of responsibility since errors in judgment affect the lives and property of the town's or village's inhabitants. Working closely with other code enforcement personnel is required, but supervision is not ordinarily a duty of this position. Does related work as required.
