<u>DISTINGUISHING FEATURES OF THE CLASS</u>: The Water and Sewer Superintendent has responsibility for the management and operations of the water and sewer system. This work involves the responsibility for the administration, maintenance and repair of water mains and sewer lines. Work is performed under general direction in accordance with established policy allowing for wide leeway in planning details of the work. Supervision is exercised over the work of all subordinate water and sewer personnel.

Plans, organizes, directs and controls the operation of municipal water and wastewater infrastructures and treatment facilities;

Manages controls and directs various computer programs used in the department's operations, engineering, mapping and finances;

Prepares the department's budget and oversees the finances and purchases;

Supervises employee time records and payroll preparation;

Schedules and ensures ongoing staff development;

Prepares and presents reports of activities to the Boards.
