# Grades 4 & 4A (Activated Sludge Plant whose designated point score is 76 points or greater) [GRADE 4 OR 4A CERTIFICATE]

- 1. Possession of a Bachelor of Science degree, or higher; OR
- 2. Possession of a Bachelor of Arts degree with at least 30 credit hours in math or science; OR
- 3. Possession of an Associate's Degree in a NYSDEC approved curriculum, PLUS 18 months operating experience at a wastewater treatment plant; OR
- 4. Possession an Associate's Degree PLUS 3 years operating experience at a wastewater treatment plant; OR
- 5. Graduation from high school or possession of a high school equivalency diploma AND SIX (6) years operating experience at a wastewater treatment plant.

**PLUS**: Completion of an appropriate approved course by the Commissioner, Department of Environmental Conservation; AND eighteen (18) months operating experience at an activated sludge wastewater treatment plant with a point score of 56 or greater, and the ability to perform necessary tests.

<u>PLUS</u>: Completion of an appropriate approved course by the Commissioner, Department of Environmental Conservation; AND twelve (12) months operating experience at an activated sludge wastewater treatment plant with a point score of 31 or greater, and the ability to perform necessary tests.

Grade 1 (All other treatment processes whose designated point score is 30 or less) [GRADE 1 CERTIFICATE OR HIGHER]

1. Graduation from high school or possession of a high school equivalency diploma.

<u>PLUS</u>: Completion of an appropriate approved course by the Commissioner, Department of Environmental Conservation AND Six (6) months operating experience at an activated sludge wastewater treatment plant and the ability to perform necessary tests.

### NOTE: POSSESSION OF THE PLANT'S REQUIRED DEC CERTIFICATE MAY BE SUBSTITUTED FOR THE OPERATING EXPERIENCE REQUIRED.

<u>SPECIAL NOTE: EDUCATION</u>: Your degree must have been awarded by a college or university accredited by a regional, national, or specialized agency recognized as an accrediting agency by the U.S. Department of Education/U.S. Secretary of Education. If your degree was awarded by an educational institution outside the United States and its territories, you must provide independent verification of equivalency. <u>DISTINGUISHING FEATURES OF THE CLASS:</u> This is routine, technical work involving responsibility during a shift for the efficient operation and maintenance of a wastewater treatment plant with facilities for chemical precipitation, sludge vacuum filtration, sludge incineration, separate sludge digestion, or any other biological oxidation process. In the case of a Type A Plant, operation and maintenance of a facility for the activated sludge process is required. The work is performed under the general supervision of an operator

qualified to be in charge of the operation of the plant. May oversee subordinate employees in the performance of their assigned duties. Does related work as required.

### WASTEWATER TREATMENT PLANT OPERATOR

TYPICAL WORK ACTIVITIES: (Illustrative only)

Starts and stops pumps, motors, air compressors, and related machinery and equipment;

Makes minor repairs to machinery and equipment;

Records reading from meters and gauges;

Treats and disposes of sludge;

Operates trickling filters;

Adds chlorine to sewage;

Takes samples of sewage for testing;

Makes necessary tests for control of plant operation;

Assists in the instruction of trainees;

Supervises the work of laborers and other subordinate employees;

Keeps a log of plant operations and related records;

Performs custodial duties in connection with maintenance of building and grounds.

FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITY AND PERSONAL CHARACTERISTICS: Good knowledge of the practices used and the equipment required in the operation and maintenance of a wastewater treatment plant with facilities for chemical precipitation, sludge vacuum filtration, sludge incineration, sludge oxidation, separate sludge digestion, or any other biological oxidation process other than the activated sludge and the stabilization or oxidation pond process; working knowledge of the principles and applications of physics, chemistry and bacteriology as applied to wastewater treatment and disposal; skill in the operation and repair of pumps, valves and related mechanical and electrical equipment; ability to read; understand and record data from gauges, scales, and meters; ability to make routine laboratory and field tests for control of plant operations; ability to understand and carry out oral and written instructions; mechanical aptitude; alertness and dependability; physical condition commensurate with the demands of the position.

### WASTEWATER TREATMENT PLANT OPERATOR TRAINEE

This is a trainee position in the competitive class for which candidates are selected on the basis of basic knowledge of elementary chemistry and general science and mechanical aptitude. Trainee period is required to satisfactorily complete the training and experience requirements of the New York State Sanitary Code for certification appropriate to the plant.

<u>DISTINGUISHING FEATURES OF THE CLASS</u>: This is a trainee position involving responsibility for learning the duties and routines in the operation and maintenance of a wastewater treatment plant and to complete the training and experience requirements of the New York State Sanitary Code for certification appropriate to the plant. The work is performed under the direct supervision of a qualified operator. Does related work as required.

### TYPICAL WORK ACTIVITIES: (Illustrative only)

Performs study and reading assignments, observes demonstrations and otherwise learns the techniques of operation and maintenance of a wastewater treatment plant;

Learns and assists in the operation and adjustments of pumps, valves, screens and related mechanical equipment;

Learns and assists in the inspection, maintenance and repair of pumps, valves, screens and related mechanical equipment;

Learns and assists in the making of tests to determine chlorine residual;

Cleans channels, screens, tanks and other equipment;

Learns and assists in the preparation and maintenance of activity records and reports:

Performs increasingly responsible duties as assigned in the operation and maintenance of a wastewater treatment plant.

### FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES AND PERSONAL CHARACTERISTICS:
