#### PAINTER

<u>DISTINGUISHING FEATURES OF THE CLASS</u>: This is skilled journeyman level work involving responsibility for the efficient performance of a variety of painting tasks requiring quality workmanship and a good knowledge of the trade. May be required to work other than daytime hours. Incumbents receive assignments from the maintenance supervisor, with considerable independent judgement is allowed for planning the details of each assignment. An incumbent in this class exercises oversite of lower-level staff who assist by performing unskilled tasks and learning the trade. Does related work as required.

### <u>TYPICAL WORK ACTIVITIES</u>: (Illustrative only)

Prepares surfaces by scraping, sanding, washing, calcimining, applying paint and varnish remover, and brushing iron surfaces with wire brush to remove rust and scale;

Paints exteriors and interiors of buildings and structures;

Primes walls, makes plastering repairs, putty's nail holes and cracks and glazes windows before painting;

Erects scaffolds;

Does finishing, lacquering, enameling, and calcinating jobs;

Fills, shellacs, and varnishes desks, tables, furniture, floors and trim;

Mixes and tints all types of paints;

Cleans brushes and equipment;

Estimates and orders materials and stores supplies;

Instructs assigned lower-level staff in proper painting techniques and use of the tools required to perform skilled painting tasks;

May incidentally perform routine work in connection with the trade.

#### FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES AND PERSONAL CHARACTERISTICS:

Good knowledge of the common practices, tools, terminology of the trade; good, knowledge of occupational hazards and safety precautions of the painter's trade; skill in painting various textures and materials; skill in the techniques required for walls, ceilings, doors and/or window sills; ability to follow oral and written instructions; ability to operate power painting equipment; ability to rig and work from scaffolds; ability to lay out work for self and others; good color perceptions; good motor and hand and eye coordination; manual dexterity; physical condition commensurate with the demands of the position.
